



Grand Rapids TRACON / vZAU vARTCC Letter of Agreement - Delegation of Airspace

Effective: 29 January 2010

Subject: Inter-facility Memorandum delegating the airspace, and area of responsibility necessary for the Grand Rapids TRACON from the Chicago vARTCC for use on the VATSIM network.



I. Purpose

- A. This agreement designates, and defines the both, the lateral and vertical boundaries between the Grand Rapids TRACON and the Chicago vARTCC.
- B. Its intent is to provide a reference for our sector files as, over time, our boundaries have proven to have shifted or moved so that different files have slightly different boundaries.
